Review of the Tasmanian State Service In addition to making submissions to the Review of the State Service, Tom Lynch was nominated by public sector unions to represent them on a reference group established by the Premier to provide advice to inform the Independent Reviewer's deliberations.

Auditor-General's Report

The Auditor-General is required to consult with key stakeholders while developing their workplan each year. The CPSU meets annually with the auditor-general to discuss the workplan and suggest areas of focus.

Tasmanian Parliament

The CPSU provides feedback on many Bills that come before the Tasmanian parliament with the potential to impact our members or their communities. In addition to providing feedback, where required we brief opposition parties prior to Bills being debated - often preparing and suggesting amendments. We also lobby and brief Legislative Council members on Bills we have specialist knowledge of after passing the House of Assembly.

Senate Inquiries

The Australian Senate conducts Inquiries into a range of issues each year. Given the many areas within which CPSU members work nationally, we are regularly called to make submissions to these Inquiries or to appear as expert witnesses. In recent years the CPSU has appeared or made submissions on a number of issues:

- Job security
- Ensuring Integrity

Union Aid Abroad works to support stronger union and social movements in thirteen locations in Southeast Asia, the Pacific, Middle East, and Southern Africa. It does this by working with thirty-nine local trade unions and community organisations through 30 projects and campaigns. Financial support for these projects comes from individuals throughout Australia, the Australian Council of Trade Unions (ACTU), Australian unions and workplaces, international grants as well as from the Australian government's overseas aid agency - the Department of Foreign Affairs and Trade.
