## **Candidate Statements**

Candidates may submit a statement to be included with ballot material. Candidate statements <u>cannot exceed 200 words</u> and must be submitted in Microsoft Word format. As per Rule 28.1(b) a candidate can only submit one statement regardless of the number of positions that they are contesting. Only statements which comply with the Rules and are received by the Returning Officer by 12:00 Midday (Australian Eastern Standard Time (AEST)) on 01 May 2025 can be accepted.

The appointment of scrutineers closes at 10:00am (Australian Eastern Standard Time (AEST)) on 19 June 2025.
