Nominations must be lodged via the following method(s):

By Email: A properly completed nomination form including all necessary signatures and attachments may be scanned and submitted as a pdf file to lEBnominations@aec.gov.au.

- 1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
- 2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.

Withdrawal of Nominations

Candidates may withdraw their nomination no later than 12:00 noon (Australian Eastern Standard Time (AEST)) on 25/08/2025. As per Rule 23.1, candidates may withdraw their nomination, and the notification must be in writing must include the signed endorsement of the nominee.

Candidate Statements

Candidates may submit a statement not exceeding 200 words to be included with ballot material. Only statements which comply with the rules and are received by the Returning Officer by 12:00 noon (Australian Eastern Standard Time (AEST)) on 01/09/2025 can be accepted.

The appointment of scrutineers closes at 10:00am (Australian Daylight Time (AEDT)) on 08/10/2025. A Scrutineer Appointment form is available from the Returning Officer.
